## KREEP-UP™ EXCLUDED ITEMS FROM WARRANTY COVERAGE

Kreep-Up™ will not provide coverage for or pay for the following:

1. Service calls to correct the installation of any Kreep-Up™ products or to instruct you on how to properly assemble or use them.
2. Damage resulting from improper handling or shipping of products, or products damaged by accident, misuse, abuse, fire, flood, improper assembly, acts of God, neglect, corrosion, modification or mishandling.
3. Shipping or freight fees to deliver replacement products or to return defective products.
